Under its Act, the Committee has a specific responsibility to recommend law reform and changes in administrative and business practices. One of its major achievements is the voluntary agreement procured from credit bureaux to comply with self regulation rules suggested by the Committee. A.L.R.C. Chairmam, Mr. Justice Kirby, has stressed many times the role of self regulation in privacy protection. However, the recent report in England on *Privacy and Computers* suggests that the time for self regulation in this field has passed.

Privacy: The Opposition Speaks Out

On the Federal Reference, the A.L.R.C. project has secured support from every political quarter. In a speech to the Australian National University, Senator James McClelland, talking on *Privacy and the Law* put it this way:

"I am pleased to be talking to you on a subject which transcends party politics. One of the more tedious aspects of my trade is that I must always find only virtue on my side of politics and only vice on the other side. ... So I am delighted to be able to tell you that there is at least one thing on which both Labor and Liberals agree: the need for the law to renew itself in the protection of individual privacy".

Senator McClelland called attention to the complexity of the task and the difficulties of securing national privacy protection in a federation:

"The problem confronting the Law Reform Commission is to strike some balance between the individual's desire for privacy, the legitimate activities of a free press and the need to collect and disseminate information implicit in being able to govern a modern society. It won't be an easy task but ... the inquiry is in good hands and it will conduct its hearings under the scrutiny of the public. I for one wish it well".

Reform Proposals

The Australian Commission's Report Alcohol, Drugs and Driving (A.L.R.C.4) contains an interesting proposal on travaux préparatoires. Clause 50 of the Bill would permit courts interpreting the Ordinance to "have regard to the report" of the A.L.R.C. This experiment in the use of L.R.C. reports is justified by reference to the Law Com.'s recommendations on The Interpretation of Statutes (Law Com. 21) and the Renton Report. The proposal attracted some interest in the Legislative Assembly when Mr. Justice Kirby explained the Report to Members.

The A.L.R.C. also proposes the abolition of a "statutory lie". Liability will attach to the result of the breathalyzer at the time of the test. At present all Australian statutes require a "relation back" from the time of the breath test to the time of driving. The blood alcohol level will rarely stand still. This false statutory presumption will no longer be required if the A.L.R.C. proposal is accepted.
