such a heavy handed approach". Following the controversy, the Bill was stood over until 1980, with a promise of further consideration.

A Director has been appointed to establish the Institute of Family Studies. He is Dr. Donald Edgar, presently Reader in Sociology at La Trobe University. The Institute will encourage and co-ordinate research on factors affecting marital and family stability in Australia. It was envisaged when the *Family* Law Act 1975 was passed and is an important step forward in the legislature's assuming the responsibility to monitor reform legislation which it enacts.

"For the first time we will have a multi-disciplinary Institute sponsored by the Government, with the basic role of building up a reliable body of information about the strengths as well as the problems of the Australian family. In other words, it will be trying to identify not only what makes marriages and families go wrong, but what makes them go right. An equally important role is the dissemination of research findings in a usable and practiced way to those who can make best use of them".

The Northern Territory Law Review Committee was established on a part-time basis in April 1976. However, in May 1979 a full time Executive Member was appointed, Mr. A.R. Miller LL.B. Mr. Miller has clerical assistance and the function of the committee is changed somewhat since it was established to "review laws and procedures affecting the Territory". The change reflects the constitutional changes in the Northern Territory. The N.T.L.R.C. operates on references from the Attorney-General of the Territory and from other bodies and private individuals. In addition it has a power of initiation. The committee wrote to over 60 L.R.C.s requesting contributions for its library. The response from within and outside Australia has been good. Reform has been asked to incorporate a note of gratitude and a plea for initiation of further exchange arrangements. The address? A.R.
