Australian Law Reform Commission (ALRC)

- *Insolvency*. Briefing papers for consultants on Unity, Principles underlying Insolvency Law, Proposals for a New Procedure in Bankruptcy and Proposals for a New Voluntary Procedure for Insolvent Companies now complete. Consultants meeting to consider paper in September.
- *Debt Recovery*. WIH. Final draft of report under consideration. Report due early 1986.

- *Admiralty Jurisdiction*. WIH. Work progressing on draft report.
- *Contempt of Court*. WIH. RP and DP on 'Contempt and Family Law', to be issued shortly. Report is due 1986.
- *Standing*. Report at printers. To be tabled in Spring Parliamentary Session.
- *Class Actions*. Project to be revived when resources permit.
- *Matrimonial Property Law*. DP and RP1 'Survey of Family Court Property Cases in Australia' distributed. Public Hearings will take place in major centres around Australia during November.
- *Evidence*. Interim Report and DP available. Public Hearings will be conducted in all capital cities around Australia during November.
- *Privacy/Sentencing: Expungement of Criminal Records*. DP due in October. Report due 1986.
- *Aboriginal Customary Law*. WIH. Report due early 1986.
- *Domestic Violence in the ACT*. Report in preparation, due late 1985.
- *Sentencing*. WIH. Papers on 'Non-Custodial Sentencing Options', 'Sentencing Discretion', 'Civil Disabilities' and 'Profile of Federal Offenders' proceeding Consultation taking place in the ACT.
- *Occupiers Liability*. DP in preparation.
- *Community Law Reform in the Australian Capital Territory*. WITH.
 - *The 1st report which deals with contributory negligence in fatal accidents and loss of consortium is being prepared.*
