# The Victorian Law Reform Commission (VLRC)

*Plain English WIH.* Issues paper on the principles of plain english drafting in the course of preparation, due April 1986. Report due end 1986.

Medicine Science and the Law WIH. Discussion paper on informed consent in the course of preparation, due shortly. A seminar program on issues relating to informed consent has been organised for 1986. Professor Margaret Somerville spoke on Informed Consent – An Overview at the first seminar of the program in late February. A report on informed consent will be released after this program is concluded.

# [1986] Reform 114

Commercial Sales and Leases WIH. A discussion paper on the Hire Purchase Act was released in early March 1986. Final report due late April 1986. It is not proposed to proceed further with this reference at this time.

Sexual Offences WIH. A discussion paper on the substantive law is due in June 1986. Report due at the end of 1986. A discussion paper on evidence and procedure is also due at the end of 1986, for final report by July 1987.

Automatism (O'Connor's Case) WIH. The final report is in the course of preparation, for release in May 1986.

*Homicide WIH.* A report on the mental element in homicide is in the course of preparation, for release in July 1986.

Juries. Background paper to be published shortly.

#### Victorian Legal and Constitutional Committee (VLCC)

Human Rights. This inquiry has now been publicly launched and a discussion paper entitled 'A Bill of Rights for Victoria? Some Issues' has been released for information. Written submissions have been called for and public hearings will commence in mid-May. Two more discussion papers will be released shortly, both dealing with whether or not human rights are adequately protected in Victoria. The second discussion paper will deal with the right to life, electoral rights, the burden of proof and the right to peaceful assembly. The third discussion paper will deal with freedom of expression.

Support Services for Victims of Crime. This inquiry has also now been publicly launched. Written submissions have been requested by 30May next and public hearings will be held in mid 1986.

Burden of Proof. The Committee reported on the burden of proof in criminal cases in November 1985 and is now awaiting the Attorney-General's response to that report before proceeding any further.

Delays in Courts. This inquiry is on hold at present, due to the launching of both human rights and the victims of crime. However, priority will still be given to delays in criminal courts from commission of alleged offence to time of trial.

Australian Constitutional Convention. The Committee has finalised its second report on the Convention and it will be presented to the Victorian Parliament shortly. It deals with the 1985 Brisbane Plenary Session, the current position of the Australian Constitutional Convention, an assessment of the Convention together with its future. Subordinate Legislation. The Committee continues to review all subordinate legislation in Victoria. Since 1July1985 the Committee ha had a greatly expanded role with the coming into operation of the Subordinate Legislation Review and Revocation) Act 1984.

## **Professor James Crawford**

Professor James Crawford, a Member of the Australian Law Reform Commission, has been appointed Challis Professor of International Law at Sydney University. His appointment commenced on 1February1986.
