would take into account the position of trust relating to that office?

- Should a new offence be included in the future Act equivalent in part to the common law offence of nonfeasance or neglect of duty, for example, wilful failure by an office holder to carry out a duty of his or her office knowing or having reason to believe that his or her failure may cause loss of life, personal injury or serious property damage?
- Should the future Act include a provision making it an offence for the holder of a public office to exercise a power or discretion vested in him or her for an improper or dishonest motive?
- Is there any other common law offence which should be included in the future Act?
