## **Public registers**

The Commission is required to maintain a number of public registers, including documents relating to:

- applications for authorisation of anticompetitive practices;
- notifications of exclusive dealing;
- conferences held on bans or mandatory product recalls;
- Commission responsibilities under Part IIIA of the Trade Practices Act (the access regime); and
- price notifications.

These documents include statutory forms of application, supporting material, submissions by interested parties, related correspondence, the Commission's draft and final determinations and records of pre-decision and predetermination conferences.

Such documents are available, or can be made available, for inspection at Commission offices during normal business hours. A fee is charged for photocopies. It is advisable to give prior notice of a request to see documents as not all are kept in all Commission offices.

The Commission voluntarily maintains summary registers listing merger matters it has considered and of enforceable undertakings given under s. 87B. These summaries and a list of sub-section 51(1) exceptions from the Trade Practices Act are published progressively in the ACCC Journal.

## Section 87B undertakings

A 1992 amendment to the Trade Practices Act conferred extensive powers on the Federal Court under s. 87B to enforce undertakings concerning future conduct given by a person to the Commission following a Commission investigation. The Commission keeps a public register of such undertakings.

The Journal lists s. 87B matters placed on the public register in the reporting period.

**Gasgo Pty Ltd,** s. 45(2)(b)(ii). Giving or threatening to give effect to a pre-emptive right clause that may result in a substantial lessening of competition.

14.10.99 undertaking not to exercise its preemptive right, contained in a gas purchase agreement between Gasgo and the Mereenie Producers, in respect of third party gas sales (in specified circumstances).

**Brumar Services Pty. Ltd.,** s. 75AU. Price exploitation in relation to New Tax System changes.

28.10.99 undertaking to place point-of-sale corrective advertising, offer refunds to customers, and institute a relevant compliance program.

**Ray White (Real Estate) Pty Ltd trading as Ray White Investor services,** s. 52. Misleading advertising about effects of the GST and New Tax System.

3.11.99 undertaking not to make further misleading representations, publish corrective advertising and to institute a trade practices compliance program.

#### Tropical Homes (Townsville) Pty Ltd,

ss 52, 53(e). Misrepresenting likely changes to house and land prices after introduction of the GST.

7.9.99 undertakings to cease making such representations, to publish a corrective advertisement and to institute a trade practices compliance program.

**Mavjon Investments P/L,** ss 52, 53(a). Making misleading representations about the ingredients of food products.

23.11.99 undertaking to develop and implement a trade practices compliance program, to provide a copy of the program to the Commission and place all of its recipes on a register. This will be monitored by an independent third party for two years.

#### Sherpa Outdoor Equipment Pty Ltd,

ss 52, 53(a). Misleading information on thermal underwear labels.

24.11.99 undertaking to relabel so composition is stated correctly; to remove garments from current packaging or alternatively use corrective oversticking; place a corrective advertisement; refund consumers; and institute a compliance program.

#### Relyt P/L and S&S Thomson Investments P/L (advertising under the trademark Q.P.R. Auto Group), ss 52, 53(e). Misleading

television advertising on effects of GST.

24.11.99 undertakings to not place advertising that states or implies that the price of used cars in general will increase as a result of the introduction of the GST; to publish corrective advertisements; and to institute trade practices compliance programs.

#### Mobile Computer Cleaning Pty Ltd,

s. 51AD. May have contravened the Franchise Code of Conduct, (Clause 10) in failing to provide a disclosure document.

30.11.99 undertaking to refund the complainant the sum of money paid for the MCC franchise less expenses, and adopt a trade practices compliance program.

#### **Copperart Pty Ltd and Aart Gerard Van Roest,** ss 52, 53(g). Misleading consumers about their rights to exchanges and refunds.

29.11.99 undertaking to publish an apology to consumers who may have been misled by the exchange or refund policies on display, offering exchanges, and in some cases, refunds; and to create and maintain a trade practices compliance program consistent with the relevant Australian standard.

**Sarai Holdings Pty Ltd trading as Zoeros Lifeskills,** ss 52, 53(e). Misleading representations about price changes for a training course because of the impending GST.

10.12.99 undertaking to cease use of similar representations in all future publications, letters and advertising, to write to any person or entity to which similar representations have been made and to implement a trade practices compliance training course.

Australasian Institute Pty Ltd, ss 52, 53(c), 55A. Alleged misleading or deceptive conduct in advertising the nature or benefits of educational courses.

14.12.99 undertakings to attend a seminar, as agreed between the parties, conducted by a person suitably qualified, on trade practices law to ensure future compliance with Part V of the Act within six months of the date of the undertaking.

**Maurice Kain Textiles Limited,** s. 48. Alleged engagement in retail price maintenance in refusing supply to Bargain Upholstery Fabrics (BUF).

12.12.99 undertakings assuring supply to BUF, not to repeat conduct, and to implement trade practices compliance program and audit and reporting arrangements.

**Tyco Australia Pty Ltd,** ss 52, 53(aa). Misleading representations in failing to perform approximately half of its contracts to inspect, test and maintain fire protection systems.

3.12.99 undertaking to compensate affected customers, conduct an internal review and upgrade its compliance program.

**Metricon Homes Pty Ltd,** ss 52, 53(e). Misleading representations about changes to building prices because of the impending GST.

22.12.99 undertaking to cease making misleading representations about the effect of the GST on building prices. Implement a trade practices compliance program subject to an annual review by an independent auditor for three years after instigation.

### Sub-section 51(1) exceptions from the Trade Practices Act

Under s. 51(1) of the Trade Practices Act, statutory exception from certain prohibitions is available for conduct that is specifically authorised or approved by a Commonwealth or State Act, or a Territory law, or any regulation under such Act, which expressly refers to the Trade Practices Act. Exceptions made by regulation are limited to two years. As part of the competition policy reform program, the Commission is required to provide a cumulative list of such legislation in its Annual Report.

The ACCC Journal will progressively update this list throughout the year.
