## **ADMINISTRATIVE REVIEW TRIBUNAL BILL**

The Administrative Review Tribunal Bill 2000 was introduced into the House of Representatives on 28 June 2000. It has been referred to the Senate Legal and Constitutional Committee for report. It is expected that the Administrative Review Tribunal (Consequential and Transitional Provisions) Bill will be introduced during October 2000.

The Administrative Review Tribunal is expected to commence operations in July 2001.
