Company Directors' Course comes to Darwin

After requests from local members and negotiations with the Northern Territory University, the Tutorial Company Directors' Course will be held for the first time in Darwin in 1994.

The School of Accounting and Business law will present the Course, which is a joint Venture between the Australian Institute of Company Directors and the University of New England. The school joins fifteen other Universities around Australia who work with the Institute.

The Course has been run since 1975 and is continually updated to provide directors and officers of companies, large and small, public or private, government departments or statutory authorities, with practical solutions to their problems. It looks at both the Conformance and Performance aspects including:

- 1. Company Law
- 2. Other laws affecting directors
- 3. Accounting and financial statements for non-accountant directors
- 4. Public investment
- 5. Human resources issues
- 6. Introductory business and corporate planning
- 7. Corporate governance

Associate Professor Mike Vallentine, Associate Dean Accounting and Business Law, was instrumental in the organisation of the Course, which is the only one of its type in Australia.

It is structured to comply with the Training Guarantee (Administration) Act 1990 and is tax deductable.

The tutorials are run in fortnightly sessions over twenty weeks from 6pm to 9pm. The Course commences on Tuesday 1 March, 1994, at the Casuarina Campus.
