

Kits ready for work experience students

The Law Society, with assistance from the Public Purposes Trust, has produced Work Experience Kits for the benefit of solicitors and students.

There are two kits: one tells the student what to expect for the duration of the week's work experience; the other is a guide for the firm and has a daily programme for the week, at the end of which practical exercises are set for the student.

The kits have been adapted from similar kits in New South Wales and Oueensland.

They explain the role of a solicitor's office, details of requisite educational qualifications (for legal, para-legal and secretarial positions), salary expectations, employment prospects, and the pros and cons of the different methods of practice (ie employed solicitor vs sole practitioner vs partnership).

The kits are the result of solicitors experiencing difficulty in keeping a student gainfully occupied for a week.

The programme is comprehensive and far more educational than sitting a student in court for days on end.

The Careers Division of the Department of Education has been advised that the kits exist, though the Society will not be distributing them to schools.

The kits are available from the Society on request from firms taking on work experience students.

Both kits (student and firm) will be given to the solicitor in charge of the student. The student should receive his/her booklet on the first day of the work experience week.
