## Listing of Matters in January, 1996

Practitioners are reminded that it has been decided that the Court will be more readily accessible to the litigating public during the January vacation period.

Generally speaking, the Court will make available such number of Judges as may be required on adequate notice, to undertake normal work during the month. The concept of having a single "duty" Judge available to attend to urgent matters will no longer be the rule.

Any party seeking to have any matter listed for hearing during the period of three weeks after January 1, 1996 should apply to do so prior to the end of September, 1995. Applications for listings after that time will be entertained at the discretion of the Chief Justice dependant upon, inter alia, the Judge time available. If one party seeks to have a matter listed for hearing during that period and the other is unwilling, a decision will be made by a Judge in light of all the circumstances.

This procedure will apply to all jurisdictions of the Court in Alice Springs as well as Darwin.

The Senate Legal and Constitutional Legislation Committee expects to be referred both the Crimes Amendment (Forensic Procedures) Bill 1995 and the Administrative Decisions (Effect of International Instrument) Bill 1995 when the Senate returns for the Spring sitting.
