d'Arenberg Wines: another great Australian wine

d'Arenberg Wines were established by d'Arry Osborn's father at McLaren Vale 40k from Adelaide in 1912 when they purchased the then well established Milton vineyards, a property with vines dating back to the 1890's.

In 1928 Frank built a winery and their first vintage produced a heavy red table and fortified wine.

d'Arry joined the family company in 1943 and he assumed full management control in 1957.

d'Arry embarked on an expansion and replanting but discovered that many of the original vines of the 1980's were revitalised by supplementary watering.

He decided to leave them, a decision that would prove far-sighted as they are the backbone of some of the finest d'Arenberg of the 1990's.

In 1958 d'Arry decided to launch his own label and by 1963 there were 250 dozen bottles under the d'Arenberg label.

In 1995 d'Arry was invested as a Patron of the Australian Wine Industry, two years after completing his 50th consecutive vintage.

d'Arenberg's most well known wine called just "Burgundy" for more than four decades was renamed in 1995 to "d'Arry's Original Shiraz-Grenache".

Family Court of Australia

New & Simplified Procedures to be Introduced

The Family Court of Australia is proposing to introduce new and simplified procedures from and including 8 January 1996.

One of the principal features of the change will be to reduce the time from filing to the directions hearing to six weeks. Currently this time stands at about nine weeks under the existing rules. In the period before 8 January and the Court is proposing to reduce progressively the time between the first return date and the directions hearing so that on 8 January 1996 all matters filed on or after that date will commence with the new six weeks period to the first directions hearing.

This will be done by reducing the present nine weeks period by one week per month until the six weeks is reached. No doubt there will be some who, for various reasons, need the slightly longer time and this will be accommodated, but on the whole most matters will be listed on the shortened time. All registries propose to commence doing this from the first working day in October 1995.

Different considerations apply to circuits because of the timing, but the intention will still be to have the six weeks apply as far as possible to all matters by 8 January 1996.
