

## 1995 Young Lawyer of the Year announced

Sharon Horgan of New South Wales is the 1995 Apple Computer Young Lawyer of the Year.

On the 27 September Sharon was presented with the award and the prize of an Apple Perform 580 computer during the Australian Legal Convention in Brisbane.

— **CASEBASE** is a case citator which enables users to search by case name, catchwords, judicially considered statutes and words and phrases. Data is indexed from a range of law reports and law journals.

— **STATE UNREPORTED JUDGMENTS** covers unreported judgments from the Supreme Courts of New South Wales, Victoria, South Australia, Queensland, West-

ern Australia and Tasmania. Data from the Australian Capital City and the Northern Territory should be included within 3-6 months.

Initially these products will only be available in Darwin but this will be extended as the hardware becomes available in other locations.
