

## Cross Border Civil Remedies

With the aim of improving support for international trade, the Australian Law Reform Commission is calling for submissions to aid an inquiry into civil remedies for cross border transactions. The focus will be on civil or commercial transactions that involve one or more countries besides Australia. In particular, the Commission will assess whether procedures for obtaining remedies can be streamlined and whether changes should be made to Australian law remedies to fit the practices abroad.

The Commission is keen receive comments on barriers to cross border remedies, the effectiveness of current arbitration arrangements and the effectiveness of current bilateral arrangements for the recognition of foreign judgments.
