#### The Faculty of Law at the NTU is to host a series of seminars on Islamic Law.

The seminars will be presented by Ms Jamila Hussain who is currently the Associate Dean (Research & Postgraduate Studies) at the Faculty.

Jamila joined the Faculty in 1995, and has been closely involved in the commencement of the Master of Laws in Comparative Laws program. She has a Bachelor of Arts and a Bachelor of Laws from the University of Sydney, and a Master of Comparative Law and Graduate Diploma in Shariah Law and Practice from the International Islamic University of Malaysia. She has written a number of articles on multiculturalism and is currently preparing a volume on strata title in Malaysia. Jamila has also served on the Cross-cultural Relations Committee of the Law Society of NSW and as a part time member of the Western Suburbs Regional Committee of the NSW Ethnic Affairs Commission.

Jamila was admitted to practice on NSW in 1986, and and was involved in general practice, mostly in the fields of Family Law, conveyancing, probate and small business. She taught law at Technical and Further Education level before moving to university teaching. Jamila spent two years living in Malaysia, teaching and studying at the International Islamic University.

The seminar program will be conducted over a five week period and willcover a wide range of topics in Islamic law. It is expected that the series will be of special interest to members of the profession and people working in areas dealing with issues which involve cross-cultural values.

## Nuffield Fellowships

The Institute of Advanced Legal Studies at the University of London is calling for nominations for candidates for the next Nuffield Fellowship Programme which will take place at the IALS in 1997.

The Nuffield Mixed Research/Training Fellowships provide support for lawyers from many sectors to undertake research and training at the IALS in London for three months between February and April 1997.

The areas for research are:

(a) research relating to an area of law shortly to undergo (or in the process of) reform coupled with in many cases, training in associated skills such as legislative drafting or skills relating to implementation and enforcement;

or

(b) creation of professional legal education programmes, usually post qualification training (ie continuing legal education) for lawyers in private practice but also development of existing vocational training by introducing new subject and methods.

Nominations for candidates wishing to undertake Research/Training Fellowships in 1997 must reach IALS no later than October 4, 1996. Candidates are advised to fax applications as soon as possible, as they are processed as they are received.

Joint proposals, involving up to a maximum of three candidates are welcome. In addition to research facilities, the practical training and network of contacts provided are tailored to meet individual or group requirements.
