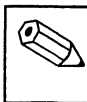

**Griffith CJ, Barton & O'Connor JJ**
- Who was the longest serving Justice?  
**Sir Edward Aloysius McTiernan - 20 December 1930 - 12 September 1966**
- Who was the shortest serving Justice (time not height)?  
**Albert Bathurst Riddington - appointed 6 March 1913, resigned 5 April 1913. Not sworn in as a justice. Shortest serving sworn justice was Sir Cyril Ambrose Walsh PC, KBE - 20 September 1969 - 29 November 1973 (died also on that day)**
- Which members of the current bench of the High Court are Knights?  
**Brennan CJ (KBE), Dawson J (KBE)**
- Who was the last Chief Justice of the High Court to be a Privy Councillor?  
**Sir Harry Talbot Gibbs PC, AC, GCMG, KBE**
- Who is the current editor of the Commonwealth Law Reports?  
**JD Merralls QC**
- Which Justice(s) of the High Court have gone on to become Governor-General of the Commonwealth of Australia?  
**The Rt Hon Sir Isaac Alfred Isaacs GCMG (GG 1931-1936)
