Programs at the University of California

The University of California invites registration in its **USA Law Programs and LL.M Program.**

The USA Law Programs include *Orientation in USA Law* which will run from July 13 to August 9 1997, and is aimed at lawyers, judges, prosecutors and defenders, notaries and others. This course is considered particularly helpful for pre-LL.M students.

Structuring an International Joint Venture is a two week program, running from August 10 to August 23, 1997. The program focusses on advanced legal planning, problem-solving and decision-making as it relates to the formation, breakup and dissolution of major multi-national joint business ventures.

In addition to the above, a **Licentiate on International Transactions Involving the United States** may be obtained by attending *Orientation in USA Law*, *Structuring an International Joint Venture* and *The Global Trading System: Substance and Dispute Resolution*, which will be offered again in 1998.

The **LL.M Program** begins in August 1997. 10-15 candidates will be accepted into the program which is run by the School of Law. The program integrates American and foreign students at all levels of study and provides candidates with the opportunity to gain a basic knowledge of the US legal system as well as to develop special expertise in particular areas under the direction of faculty members.

Early registration in the USA Law Program courses is recommended and an application packet for the LL.M program is available from the University.
