

Cavenagh Theatre presents — *Witness for the Prosecution* —

a rare opportunity to enjoy a court room drama
in an authentic environment

Cavenagh Theatre has been allowed the rare privilege of presenting Agatha Christie's *Witness for the Prosecution* in Court 3 at the Darwin Supreme Court.

Justice Angel has graciously permitted access to the Court for the staging of Agatha Christie's suspenseful play about a London murder trial. Access has been facilitated by Courts Property Manager Kevin McShanag.

An immediate success from its first staging in London on October 28 1953, *Witness* moved to Broadway to win the New York Drama Critics' Circle Award as Best Foreign Play of 1954.

In 1957, Charles Laughton, Marlene Dietrich and Tyrone Power played the defence barrister, the 'witness' and the defendant in Billy Wilder's powerful film adaptation of the play, and in 1982 the film was remade with an all star cast including Ralph Richardson, Deborah Kerr, Beau Bridges as the (defendant), Donald Pleasance and Diana Rigg.

To be directed by Lois McDonald, the Cavenagh Theatre production of *Witness for the Prosecution* will feature Malcolm Moore as the defence counsel, Phil McKeiver as the defendant, Amelia Jane Hunter as the Crown Prosecutor and Karen White as the key witness. The large cast is drawn from a variety of backgrounds and includes two solicitors and a former police officer.

Community assistance towards staging this large cast production has included the loan of wigs, legal robes and regalia by members of the legal fraternity and financial assistance by way of sponsorship from the NT Government through the Office of the Arts and Cultural Affairs.

On presenting *Witness for the Prosecution* in the Supreme Court, director Lois Macdonald says "it is a great experience for the actors and crew to use this unique venue which lends authenticity and veracity to the stage production."

Performances will be staged on Friday and Saturday nights of June 14, 15, 21, 22, 28 and 29 and July 5 and 6.

The season is strictly limited to these 8 performances and early bookings are recommended to ensure a seat. Ticket prices are \$15 full price and \$12 student and pensioner concession for gallery seats.

Premium seats in the jury box are available for group bookings at \$250 for 10 seats. Special school group bookings are also available.

National Inquiry into Children and the Legal Process
