

## Australian Judicial Conference Griffith University

The Australian Judicial Conference, comprising over 250 judges and magistrates has formed an association with the Griffith Law School, Brisbane which will provide a research facility and administrative assistance to the Conference.

The principal objects of the Conference are to ensure the maintenance of a strong and independent judiciary in Australia as well as to foster an understanding in the community of the role played by the judiciary.

The Chairman of the Conference, the Honourable Justice Ian Sheppard of the Federal Court said in Sydney: "There are many matters on which judges must be slow to comment, but it is appropriate that the benefits of an independent judiciary to the community be more widely known and understood. The work of the Conference, aided as it will be by support and research provided for it by Griffith University will eventually provide a sound basis for informed and constructive public discussion on this important subject."

The Conference plans to run seminars and workshops around the country and to consult with interested groups to identify areas of research.

The Dean of Griffith University Law School, Professor Stephen Parker noted that the University was proud to be providing support for the Conference and mentioned the attendant benefits to staff and students from the association.
