

## 'Best Ever' Mock Trials

The 1997 Grand Final of the Interschool Mock Trial Competition was debated at the Law Courts Building in Alice Springs by Darwin region winners - Katherine High School, and St Phillip's College, representing the Alice Springs region.

Katherine High School was a first time entrant in the competition and faced the additional burden of travelling to Darwin for each of the rounds - a commitment that paid off as they were surprised and delighted to come through as the team to represent the northern region.

Tribute was paid to the quick thinking of the barristers on both teams, all of whom attracted high scores for their roles from Justice Kearney and their solicitors, who did an excellent job of instructing. The witnesses managed the difficult task of dealing with examination-in-chief and cross-examination and it is in this role that the dramatic talents of the student participants are most to be admired. All witnesses were given a perfect

score by the adjudicator. Justice Kearney also praised his mock associate and the clerk of court, whose task it was to ensure that the trial ran smoothly.

Following the presentation of certificates and trophies to both winners and runners-up, the teams, teachers and coaches retired in high spirits to *Oscar's Cafe* for a post-final celebratory dinner.
