International Product Liability Under Conference Spotlight

The United States and Japanese experience in product liability law will be contrasted at an international insurance law conference in Singapore in November.

Kevin Coughlin, a partner with McElroy Deutsch & Mulvaney in the US and Masato Ata, a deputy manager, liability insurance section, non-marine underwriting department of Mitsui Marine and Fire Insurance Co. in Japan, will address delegates on product liability issues.

The first AIDA (Asia Pacific) Insurance Law Conference is at Singapore's historic Goodwood Park Hotel.

The November 9 - 11 conference has been scheduled to attract insurance lawyers returning from the biennial International Bar Association conference in New Delhi from November 2 - 7.

The Singapore conference - *Current Legal Issues Affecting Insurers and Reinsurers* - has been coordinated by the Australian Insurance Law Association and the Insurance Law Association (Singapore).

The conference is under the patronage of AIDA, Association Internationale de Droit des Assurances, better known as the International Insurance Law Association.

This conference will be the first regional AIDA meeting and will bring together 20 expert speakers from the insurance and legal professions worldwide, to cover topics ranging from fidelity claims, ADR, and directors' and officers' liability to product liability and health insurance. The conference will also include a mock arbitration of a reinsurance case.
