## Human Rights Register

The Catholic Commission for Justice, Development and Peace has created a Human Rights Register, which, it is envisaged, will record developments in human rights, both positive and negative.

The register will record occurrences in the human rights area from September 1997 until May 1998, as they occur in Australia. The focus of the register is domestic, but it does not preclude Australia's signing or refusal to sign conventions on human rights.

The Commission invites notification of human rights developments from non-governmental agencies and anyone wishing to respond should contact the Law Society in the first instance.
