## Guidelines for the Distribution of the Port Arthur Victims Fund

The Attorney-General for the State of Tasmania is to approve guidelines for the allocation of a fund created from the forfeiture of money and property of Martin Bryant, convicted of the shootings and other offences at Port Arthur on 28 April 1997.

The beneficiaries of the fund are victims of the offences and may include persons:

- killed or injured at the time of the tragedy;
- wholly or partially dependent on the deceased;
- who have suffered an injury of a psychological nature as a consequence of trauma or bereavement;

- who have suffered damages or destruction of property while assisting the police during or immediately after the events at Port Arthur.

A 'victim' can include a person who is a member of the victim's immediate family who, though not physically injured or necessarily even at the site at the time of the shootings, has suffered an injury in the sense of an impairment to mental health arising out of the events at Port Arthur. A 'dependant' can include a person reliant on services provided by a deceased victim if such services were reasonably necessary and capable of being quanti-

fied in monetary terms.
