to collect child support. The NWJC has appealed to Government and asked that the Bill should be deferred until essential re-modelling is undertaken, published and debated.

I would like to thank those members who attended at our Abortion Debate meeting. A consensus was reached and we have agreed on a strategy to implement that consensus. # MT Lawyers for Reconciliation

### National Reconciliation Week

National Reconciliation Week runs nationally from 27 May until 3 June and is timed to to mark the anniversary of the 1967 referendum on constitutuional change related to Aboriginal people which falls on 27 May. It's closing date, June 3 celebrates the anniversary of the Mabo decision National Sorry Day is on May 26.

This year, NT Lawyers for Reconciliation's project for National Reconciliation Week involved school visits by a dozen or so members/supporters of LFR who spoke to groups of students about reconciliation and associated legal issues.

The speakers included John Duguid, Tony Fitzgerald, Kate Halliday, John Hughes, Melanie Little, Dominic McCormack, Pat McIntyre, Greg Roche, Cathy Spurr, Sunila Srivastava, Bruce Taylor and Tony Young.

The participating secondary schools were Casuarina Senior, Kormilda and St John's Colleges and Darwin, Driver, Nightcliff, Sanderson and Taminmin High Schools.

The addresses given during the school visits covered a range of issues. Included among these were meaning of reconciliation, the a brief overview of the history of European

attitudes to and dealings with Aboriginal and Torres Strait Islander people, the background to National Reconciliation Week and the reasons why it is important, the significance of the Mabo decision, the purpose of National Sorry Day and the policy of assimilation.

Members of NT Lawyers for Reconciliation reported some lively debate at some of the sessions.
