The Council of the Law Society this year has been involved with the following major matters

The Structure of the Legal Profession and the National Legal Services Market

The Council has established a Structure of the Legal Profession Committee, Members of the committee are Donna Drier (convenor), Alan Lindsay, Eileen Terrill, Ian Morris, Duncan McConnel, Susan Porter and Steve Southwood.

The Committee has been set up to:

- a) forward plan the introduction of the changes to the structure of the profession which have been recommended at the National level to ensure the profession is competitive and its structure complies with National Competition Policy.
- b) generally recommend changes to the Legal Practitioners Act
- review cost provisions of the Supreme Court Rules
- d) review structure and funding of the Law Society
- e) negotiate assistance from the Law Council of Australia and other jurisdictions

To achieve (a) above the Law Society has retained Sue Oliver to provide a detailed report on each of the structural matters which are being considered by the Law Council of Australia.

To date, Sue Oliver has produced reports in relation to the:

- a) travelling Practising Certificate regime
- b) the National Model Conduct Rules

The Council of the Law Society will be circulating recommendations in relation to (a) and (b) above based on Sue Oliver's report prior to 19 September 1998.

Practising Certificate

It has been proposed that a national regime should be set up whereby admission to practice in any one state or Territory would enable a legal practitioner to practise in all States or Territories, the system would work in a similar way to which driving licences work.

Comments on legislative Amendments

The Council of the Law Society and in particular, Ian Morris has made detailed recommendations in relation to the recent amendments to the Work Health Act.

Richard Coates and Jacek Karczewski have made submissions at the national level in relation to:

- Legal Aid
- · Dietrich Applications
- · Right to Silence
- · Procedure in Criminal Trials
- Disclosure of the Crown's Case in Criminal Trials

In addition, the law Society Council has made recommendations in relation to:

- a) the form of the Constitutional Convention.
- b) the Magistrates Act
- c) the Coroners Act (David Farquhar is to be thanked for his assistance in this regard)
- the Law Society also had a representative on the Law Reform Working Party which has been set up by the Attorney-General.



The Council of the law Society has been opposed to mandatory sentencing and members of the Council have spoken out against it.

Young Lawyers

Duncan McConnell has been representing the concerns of young lawyers. Concerns have been raised about the conditions of employment of articled clerks and a more detailed report has been sought.

Northern Territory University

The Law Society has been involved in the reaccreditation of the Law Degree at NTU. Our representative has been Susan Porter. A primary recommendation of the Law Society has been that law Students should not be required to do non-law common units.

Continuing Legal Education

Duncan McConnell has been the Council member responsible for Continuing Legal Education. Duncan has arranged a number of lectures and seminars in the past 12 months.

Legal Ethics and Disciplines


