Legislation on Collection of Genetic Material

On 25 March 1998, the Senate referred a private Senator's bill known as the Genetic Privacy and Non-discrimination Bill 1998 to the Legal and Constitutional Legislation Committee for inquiry and report by 11 August 1998. The Bill, if enacted, will make legal provisions for mechanisms by which human genetic information may be collected, stored and used.

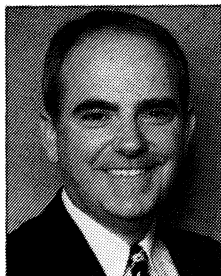

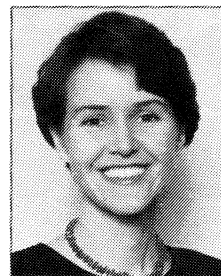
