#### Domestic Violence

Recently Domestic Violence Legal Help (DVLH) released a Discussion paper entitled "The Criminal Justice Response to Domestic Violence: The Myth Continues...". The paper highlights the ongoing reluctance of police to exercise their powers pursuant to sections 4 and 6 of the Domestic Violence Act (to obtain urgent restraining orders in a domestic context) and the

current dialogue between DVLH and prosecutions regarding the hiatus in representation in subsequent mentions of restraint orders when police have taken out an initial restraint order. These are important issues to be debated.

# Report on Retention of Legal Practitioners (WA)

The Law Society of Western Australian and Women Lawyers of Western Australia have jointly surveyed and reported on the retention of lawyers in WA. Practitioners exiting the profession in WA were surveyed after it was realised that many were leaving practice with 3-7 years experience. There is reason to believe that this is also the case in the NT.

The report stated that it sensed that "the practice of law has become increasingly estranged from the interests of the community it is intended to serve" and recommended changing the 'culture' of legal practice. The legal profession needs to be "clear about the attitudes and aptitudes it believes are necessary for good lawyers". The report also highlighted the importance of good management in a legal practice.

#### **TEWLS Projects**

The Top End Women's Legal Service has funded a women's art project in Kunbarllanjnja and one of the results is a wonderful poster entitled "Are we looking after our kids the right way?" - highlighting the consequences of alcohol abuse in the community. TEWLS is also producing radio scripts in 16 NESB languages (including Spanish, Thai, and Greek).
