Women in Custody

We have recently become aware of the statistics of women sentenced to imprisonment in the Northern Territory, revealing a dramatic increase in numbers in the past 2 years. It is greatly alarming to see that there has been a four-fold increase in the numbers of indigenous women sentenced to terms of imprisonment, and a doubling of non-Indigenous women. This is unacceptable and an issue which I believe NTWLA should be prepared to take on board. Please contact Committee members with your views on the issue.
