

Whiskies of the World

Grant's

In 1898, Pattison's, a major blender and wholesaler of whisky in Scotland, went bankrupt, causing devastation amongst whisky distillers. Faced with financial ruin William Grant, with true entrepreneurial spirit, turned adversity to his advantage and expanding upon his skills as a fine whisky maker, created his own whisky. Grant's now, as then, has a traditional, yet individual taste. Today, Grant's is the fourth largest selling blended Scotch Whisky in the world.

Glenfiddich

In 1887, after 20 years planning, William Grant, helped by his nine children, built a distillery at Glenfiddich, near Dufftown, Scotland. He chose the site because of the pure springs which, to this day, ensures Glenfiddich is different from all other malt whiskies. Recognised as the brand that created the malt whisky market as we know it today, it now accounts for one in four bottles of single malt Scotch Whisky sold in the world.



Clan Campbell

Clan Campbell is a blend of the fine highland malt and selected grain Scotch Whiskies. It has a pale golden colour with an intensely fruity nose. It is a smooth, light delicate whisky, full of flavour and character.

Jameson Irish Whiskey

Jamesons Irish Whiskey, established in 1780, has joined the elite ranks of the world's top 100 International Spirit Brands. The malted barley used in the production is dried by hot air in a closed kiln, not over an open peat fire, as is Scotch Whisky. Thus the smokey taste traditionally associated with Scotch Whisky is absent from the Irish Whiskey and is instead

replaced with the soft sweetness of the barley.

Bushmans Malt

This comes from the oldest distillery in the world and is the only aged Single Malt Whiskey from Ireland. Bushmans Malt has a warm sweetness in the aroma, a clean delicious maltiness and a dry perfume finish without smokiness. It is made from the finest Irish Barley, triple distilled in copper pot stills and matured for at least 10 years.

White Heather

White Heather is a deluxe blended Scotch Whisky distilled, matured and bottled in Scotland. The malt whiskies in White Heather are all aged a minimum of five years. It has an amber gold colour, full bodied with a malty chocolate-like flavour. The finish lingers and is soft, smokey and satisfying.

Johnnie Walker Red Label

The world's best selling Scotch Whisky has been awarded another gold medal at the 29th International Wine and Spirit Competition for its outstanding quality.
