The gall of it!

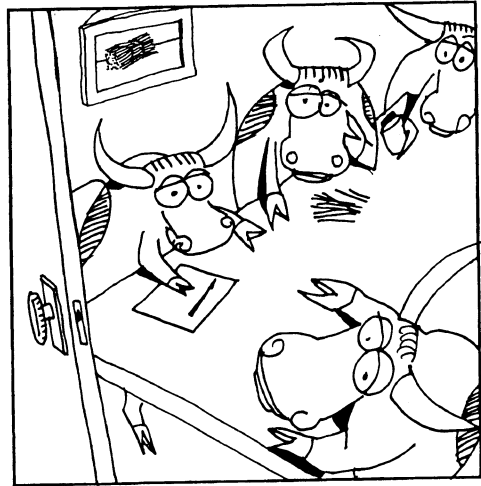

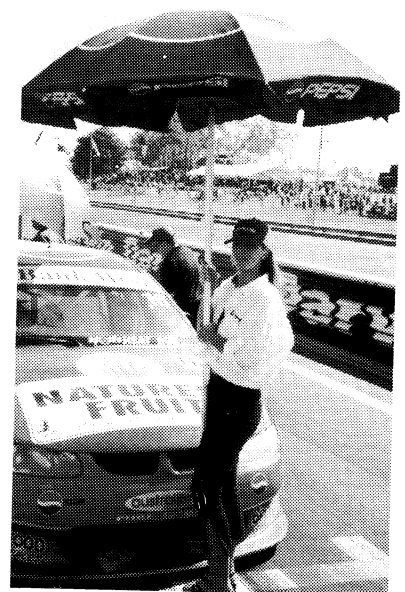
