salary.*

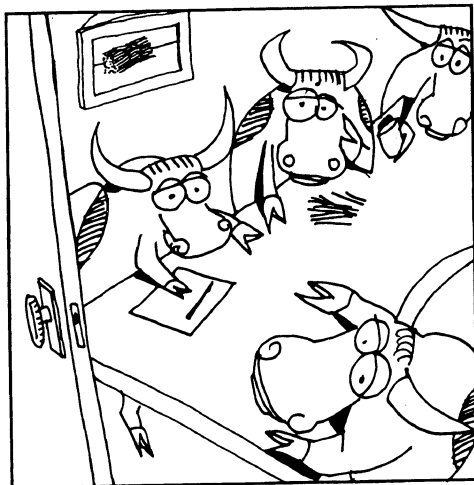
## Triple shock
