

SUPREME COURT SITS AT GUNBALANYA

The Supreme Court sat for the first time at Gunbalanya on 22 May 2001 to hear evidence from members of the local community.

The Court was set up in the Demed Building which is the organisation that coordinates the outstations in the Gunbalanya area. The reason for the

court sitting at Gunbalanya was to hear an application on behalf of a prisoner who had been detained as an habitual criminal since the expiration of his sentence in 1993. The Applicant was represented by Suzan Cox of the NTLAC and the Respondent, represented by Rex Wild QC with Jo Downe of the DPP, called a number of witnesses, all of whom lived at either Gunbalanya or on outstations in the region.

At the time of Counsel's application to have the court heard at Gunbalanya, rather than Darwin, it was agreed by His Honour, Justice Bailey that it was appropriate for the court to sit at Gunbalanya to hear evidence from that community.

At the conclusion of the hearing, all parties agreed that the holding of the court in the community was of great benefit.
