Draft Information Bill 2001

The Northern Territory Government seeks public comment from any interested parties on draft legislation that has been tabled in the Legislative Assembly.

The draft Information Bill 2001 proposes the establishment of statutory regimes for:

- Freedom of Information (Access to Government Information)
- Privacy Protection
- Record keeping and records management in the public sector

The Government is particularly interested to receive views as to whether the draft legislation strikes an appropriate balance between the right to access government information and the necessity to protect, in the public interest, certain types of information and the privacy of individuals in respect of their personal information.
