#### Sunset Cruise



# Australian Young Lawyers Committee ("AYLC")

On 14 March 2001 I attended the meeting of AYLC by telephone. Each representative was given the task of finding a sponsor for the Australian Young Lawyers Award 2001. I created a shortlist of eight recruitment agencies, one of which, Hughes Castell, was ultimately chosen as sponsor of the award. As part of the sponsorship program Hughes Castell were given naming rights and their logo was placed in an advertisement for the Young Lawyer Awards published in each jurisdiction's law journal. The advertisement appeared in the July edition of Balance and was sent to all NTYL members via email.

The winners of the award can be found in the NTYL article in October's *Balance* together with the report of the Canberra AYLC meeting.

On 15 June I attended a face to face AYLC meeting in Sydney. The action sheet for the meeting required all members to provide the administrator with all surveys, Awards and Codes in place for young lawyers in each jurisdiction. I informed the administrator that the Northern Territory does not currently have an award that covers the employment of employed solicitors or articled clerks in the NT, however, NTYL has relied upon the Law Council of Australia's Guidelines for the Employment of Employed Solicitors and Articled Clerks which was adopted by the Law Society of the Northern Territory in 1997. #### "Golden Gavel" Competition

AYLC has proposed a national "Golden Gavel" competition. For over ten years the NSW Young Lawyers has been running a breakfast function "Golden Gavel" competition to coincide with Law Week during May each year. A letter is forwarded to all managing partners of the largest city law firms encouraging them to nominate a young lawyer to enter the competition and to book a table to cheer on their competitor.

Members of NSWYL brainstorm ideas for an adjudicator and a senior member of the bench is invited to attend the breakfast and act as a judge. The breakfast is usually hosted at one of the CBD's five star hotels and 350 people normally attend the breakfast. The NSWYL Committee members submit funny topics with a legal element and each competitor speaks for a maximum of five minutes. This year's topics included: "A night at the HIH Christmas party"; "Top tier law firms: outwit, outplay, outlast"; and "Survivor III: the law firm".

At the June AYLC it was agreed that the first national competition would be conducted at the NSW Young Lawyers assembly in 2002. This was confirmed at the Canberra AYLC meeting. Sponsors are currently being sought for the event and the media will also be asked to cover the event.

This is a great concept which all NTYL members are urged to take an interest

in. If the NT competition is held at the beginning of the 2002 and a winner is selected, a representative can participate in the national competition in November 2002. The NT winner and their employer will receive national exposure and the competition will highlight the talent that resides in our jurisdiction.

### Special General Meeting

On 2 November 2001 a General Meeting was held at Blush Wine and Cigar Bar to discuss issues raised by members with respect to the Association's "progress". A list of agenda items was forwarded to the committee on 4 October 2001 and those items were included in the agenda for the 2 November 2001 meeting. Prior to the meeting the NTYL committee provided members with AYLC and NTYL minutes from this year and a letter addressing some of the agenda items raised.

Reports of the AYLC meetings were tabled at the General Meeting and the floor was opened for discussion. The two major issues raised were the standard of legal education at the NTU/Practical Legal Training in the Northern Territory and the NTYL's input on the Law Society. Two committees were formed to provide submissions in relation to these issues. If any members would like to assist those committees please contact Sarah Hawke and Simone Menz of Cridlands or Susie Slade of Ward Keller.

With respect to input on the Law Society, NTYL members can actively participate by selecting preferred candidates prior to the Law Society's AGM in September 2002 and encouraging members to vote for those candidates on the day. Sarah Hawke is currently a councillor on the Law Society and can assist members if they have any queries. All members have the ability to approach any of the Law Society's councillors.

Simone Menz undertook to redraft

NTYL's constitution and will provide members with the draft prior to the association's AGM in February 2002.

Members voiced their concern that an "appropriate" member should be the AYLC representative for NTYL. Since the creation of NTYL the president of NTYL has attended AYLC meetings on behalf of NTYL. If he/she is unable to attend, the vice-president attends. The AYLC requires a commitment of two years to provide continuum, however this may vary depending on the constituent bodies' practice of retaining their leaders for a period of more than one year. At the General Meeting it was suggested that a protocol be adopted for selecting the AYLC representative which will be discussed at the AGM in February 2002.

The NTYL currently has a membership of 60 which has increased threefold since 1997. Forty members attended the General Meeting at Blush, so there is some interest in what NTYL is doing and trying to achieve. Some members expressed that they joined for the CLE program, advocacy course and social interaction at functions that NTYL provides during the year and from the abovementioned list we can state that the committee has provided all three.

The meeting was very productive and has set the scene for bigger and better things in 2002. If any NTYL members would like a certain event or CLE subject provided, within reason, they should feel free to contact any of the committee members who will be more than happy to oblige.

## Workplace and salary survey

A workplace and salary survey has been sent to all members to complete. The survey will give the committee and members a picture of employment conditions for employed solicitors and articled clerks in the Northern Territory. The AYLC has requested all representative bodies provide results from their surveys so that a national survey can be conducted. At the present time the NTYL committee has received 40% of the surveys. All members are urged to place the completed survey into the rounds box.
