Readers Digests predicts boom for litigation lawyers

Reader's Digest has come up with a new moto for Australia: If anything goes wrong, sue, following an exclusive survey in their April magazine which suggests Australia is becoming a more litigious society.

According to the survey, one quarter of Australians would sue a doctor who prescribes medication that interferes with a herbal remedy making them sick; even though the patient hasn't told the doctor about the remedy, they believe the doctor should have asked.

The Reader's Digest goes on to reveal such insights as:


• One in five Australians believe a supermarket customer who gets sick after eating food that was not refrigerated at home has the right to claim financial damages if the need for refrigeration wasn't stated on the label — even though the item was selected from the chilled section at the supermarket.

- One in seven believe that

 a bushwalker who
 injures himself by
 tripping over a tree root
 is entitled to
 compensation claiming
 the local council failed
 to provide warning signs
 about uneven surfaces.
- One in ten believe that if parents should sue if their young child wanders onto a neighbour's property where she picks and eats a poisonous plant making her sick.
- One in fourteen Australians believe a householder who injures himself on a do-it-yourself project after watching a television segment is entitled to financial compensation, claiming the oversimplified task.

These figures were gathered from a survey of 1003 Australians in January 2001, which also revealed that the ACT

and Tasmania are more in favour of compensation and West Australia less so.

The Society welcomes him to the office.


Chris Rowe
