## Work Health Amendment

Changes to the Work Health Act have been passed in parliament and will come into effect soon. The changes are wide-ranging and are a result of a recent review of the Act.

Work Health Minister Syd Stirling told parliament: "These changes (to the Work Health Act) are aimed at improving the overall efficiency of the Workers Compensation Scheme...".

Capitation fees are again an issue. A draft report prepared by the national body has been distributed and we are currently assessing its impact on the Northern Territory.

The proposal at this stage is that 10 percent of the fees collected would be paid to the national body.

This would be used towards airfares and other expenses for members. The NT would be better off under this scheme, as it is difficult for us to raise the funds needed to finance airfares and accommodation from our membership fees.

We do not have the membership to do this. It is also something the national body must consider, as they will be subsidising the smaller states and territories.

We have been invited by the NT Government to make a submission to them on the review of the *Ombudsman (NT) Act*. If anyone is interested in contributing to this Review, please contact me and I will provide you with the relevant information.

We have also been invited participate in a survey by the Chief Minister's Department, called *Engaging with the Community*.
