



# Family law reforms a step in right direction: LCA

The Law Council of Australia (LCA) has welcomed a number of family law reforms announced by the Federal Government, labelling the changes as a step in the right direction.

As part of the shake-up, separating couples may attend newly-created Family Relationship Centres, which will provide information and referral to primary dispute resolution service providers.

Law Council President Bob Gotterson QC said, "We know that only two percent of separating families need judges or magistrates to eventually make decisions on parenting matters. This move may help the other 98 percent of people settle on sensible parenting arrangements earlier".

He said changes that affirmed that the children of separating couples have the right to be with both parents were also positive.

"The Family Law Act already recognises children have a right to contact, on a regular basis, with both parents and other people significant to their care, welfare and development. These latest proposed amendments to the Act will help reaffirm these rights."

But Mr Gotterson warned that there was a limit to what could be achieved by court orders.

"Real change in the way that parents share the care of their children after separation requires change in workplace structures and the way in which families organise themselves," he said.

"It is not in children's best interests to force post-separation parenting arrangements which are radically different to the arrangements that existed prior to separation."

Mr Gotterson highlighted the fact that there was more work ahead.

"The Law Council has pressed for many years for the Government to review the operation and workload of the two courts that deal with family law. Unfortunately, the House of Representatives Inquiry last year was not asked to undertake this task, but it is very important if Australia is to develop an ideal process for dealing with post-separation family issues," Mr Gotterson concluded. ①
