Admissions cheaper by the dozen

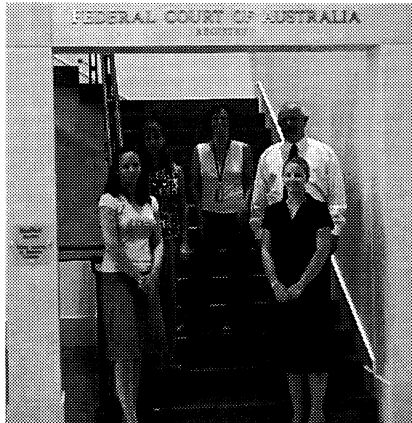
It was a very crowded Bar table that confronted Chief Justice Martin at the March admissions hearing in Court One of the Supreme Court.

The Federal Court has moved



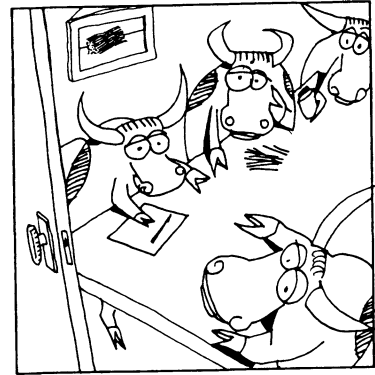

The Northern Territory District Registry of the Federal Court of Australia has relocated the Supreme Court Building in State Square, Darwin.
