The Law Council of Australia recently announced that it has adopted the Model Equal Opportunity Briefing Policy for Female Barristers and Advocates (the Model Policy). The Law Council believes that this is an important starting point from which a harmonised approach for equal opportunity briefing practices for female barristers and advocates might be achieved. It acknowledged the contribution of AWL.

The Law Council has indicated that its next step will be to promote the policy

and encourage law firms to adopt measures in their day-to-day practice. Notably, prior to the Law Council's adoption of the Model Policy, Mallesons Stephen Jaques adopted a similar policy across its practice groups nationally.

On 19 March 2004, the Federal Attorney-General announced that he would support the Law Council's adoption of the Model Policy. He also announced a review of the Federal Government's briefing practices.

Lastly, on a sadder note, NTWLA mourned the passing of one of its members, Shirley Rowe, at a function on 12 March 2004. Shirley was originally from Melbourne and her family very kindly forwarded personal information to me about Shirley's life which I shared with the members who attended the function. She was a committed advocate of human rights and indigenous people. Shirley left this life precipitously. Her passing is a reminder to us all that, even though we lead busy, professional lives, we need to balance work, life and family, support others and allow others to support us. I thank Morgan Buckley and Hunt & Hunt for their support in the arrangements for this function.
