Law Week and new legislation keeps the LSNT on its toes

Well, May was a very busy month. As most of you will know, Law Week ran from 15 to 23 May 2004. Law Week was "jam packed" this year, starting with the traditional cricket match on Sunday between the President's XI and the Chief Justice's XI (captained by Justice Mildren).

I must say the feedback we got from both Alice Springs and Darwin was very positive and we feel honoured that Jim agreed to speak to us as his last official function for the Red Cross before moving on to work with Amnesty International. Then of course there was the lunch in Darwin. It was very well attended and everyone appeared to have a great time. I would like to thank everybody for their continued support of Law Week and I would also like to thank our very hard working Secretariat who spent considerable time organising Law Week which, as you will appreciate, is more than just the lunches.

In other news, the Council and Secretariat have been extremely busy dealing with the various pieces of new legislation, in particular the Legal Practitioners Amendment (Costs and Advertising) Act which all of you should be very familiar with by now. In addition the Council continues to work on the model laws, which have taken a substantial commitment from the Council and the Secretariat. With all the legislative changes and proposed legislation changes such as the model laws, the legal practitioner will be the most regulated group of professional in Australia!

Tort Law Reform continues to be a hot topic requiring attention. Steve Southwood QC and I continue to work on the Law Council of Australia Committee Working Party, which is currently working on information kits to cover the major reforms implemented thus far. The LCA hopes to have the kits available for distribution within the next couple of months. The purpose of the kits is to assist with understanding the reforms; more information will be forthcoming shortly.

Finally, on 8 April 2004 His Honour Justice Angel celebrated 15 years on the bench and I would like to take this opportunity of behalf of the LSNT and our members to commend His Honour on his 15th anniversary.
