The purpose of the kits is to provide members with a summary of the reforms and additional relevant information. Interested members can obtain a copy of the kit from the Law Society NT Secretariat.

Michael Grove, Tony Young, Ian Morris (as my nominee) and Barbara Bradshaw continue to attend the Northern Territory Tort Law Working Party. The feedback we are receiving regarding further reforms is encouraging and we continue to spend quite a bit of time on Tort Law Reform issues.

On 29 July 2004 the Law Society met with Cheryl Richardson from Marsh, our insurance brokers for Professional Indemnity Insurance (PII). We have been advised by QBE that the Quality Practice

Review process and the additional risks seminars and CLE seminars are likely to be well-regarded by prospective insurers in the future. Indeed QBE has offered a ten percent per practitioner reduction in premium for the next policy-term for those firms that have participated in the Quality Practice Review undertaken by Le Messurier Harrington. Speaking of PII, most of you should have by now received insurance renewal packages. If you have not done so, please contact the Law Society.

The LSNT continues to work hard on the 'usual suspects' - FSRA, Model Laws and new legislation such as the Costs and Advertising Act. All of these issues take considerable work from the Society.
