The 2005 Human Rights Art Awards, organised by Darwin Community Legal Service, were announced at the opening of the exhibition in the NT Supreme Court on Thursday 8 December.

The awards were:

Major award (sponsored by the Chief Minister and Don Whyte Framing) - Justin Tutty for 'Price of Petrol'.

Human Rights Award (sponsored by Justice Sally Thomas and William Forster Chambers) - Jan Milner for "Our History of Human Rights - Why Weren't We Told?"

Women's Achievement Award (sponsored by Magistrate Jenny Blokland, Jamie Gallacher and Barbara McCarthy MLA) - Imbi Davidson for "Burning of Baghdad".

Secondary School Award (sponsored by the Law Society NT) - students from years 8 to 10 at Kormilda College for "With One Voice".

Primary School Award (sponsored by the NT Anti-Discrimination Commission) - class 1-2 Green at Howard Springs Primary School for "Celebrating Sport, Physical Education & the Rights of Children" and "Wishing Boats".

The former work has been purchased by Tony Fitzgerald at the ADC as a present for Dr Sev Ozdowski, the Human Rights Commissioner.

Teacher Mark Green emailed DCLS and said "thank you for organising the exhibition and competition it really helped me to teach students about human rights".

3D Award (sponsored by the NT Legal Aid Commission) - Aly de Groot for "People in Nowhere".

Judge Dallas Gold (from Raft Art Space) gave two encouragement awards to primary school students Ruby Josif for "What Human Rights Means to Me"

and to Jesse Gohier-Fleet for "Invaders from Mars".

Judge Penny Campton (activist/artist) gave a commendation award to Jeannie Gadambua for "Aboriginal Survival".
