## Barrister granted QC

One of the Northern Territory's leading barristers, Michael Grant, has been appointed a Queen's Counsel. He is the first Territory-born practitioner to be commissioned a QC in the NT.

"He is an outstanding barrister and very much deserves this honour," Attorney-General Syd Stirling said.

"Mr Grant was highly recommended for the appointment by the Chief Justice, and had the support of the legal community. He has a strong litigation record and possesses all the qualities you expect for this distinction.

"It's also gratifying that he is a home-grown lawyer who has remained committed to and involved in the Territory justice system.

"I heartily congratulate him on his appointment."

The process for appointing QCs starts with nominations from the ranks of practising lawyers. The applications are then considered by the Chief Justice, who consults with his fellow judges and others, including the Presidents of the Bar Association and the Law Society.

The Chief Justice then makes a recommendation to the Attorney-General, who in turn makes a recommendation to the Executive Council.

## ABOUT MICHAEL GRANT

Mr Grant, 43, was born in Darwin and spent his early years in Pine Creek. He is the son of former Assistant Police Commissioner Saus Grant and Norma Grant (who was one of the Territory's first police women, and who subsequently worked as a teacher and librarian).

Educated at St Mary's Primary School and St John's College, he completed his schooling in Sydney after Cyclone Tracy.


Mr Grant received his Bachelor of Laws degree with first class honours from the University of Queensland.

He completed his articles of clerkship at the then-NT Attorney-General's Department and was first admitted to practice in the NT in 1993.

He was appointed Litigation Director in 1998.

Among the cases he worked on during his time at the Department included the constitutional challenges to the voluntary euthanasia legislation and the mandatory sentencing legislation.
