Practice Direction: Crimes Victims Assistance Act

The following practice direction is issued pursuant to section 21 of the Local Court Act and will apply from 14 December 2005.

Background

Section 8 of the Crimes Victims Assistance Act states that the court shall not issue more than one assistance certificate for each application for assistance. In the past this has been read to mean that for each separate offence there must be a separate application form. This has led to the proliferation of unnecessary paperwork when the applicant is alleging a number of offences against the same offender. To simplify the process for these matters the following procedure will now apply.

Procedure

1. Where there are multiple offences/applications for one applicant relating to one offender then one form shall be filed in relation to all applications for assistance. The form to be used is form 9A of the (Crimes Victims Assistance Act) with a separate paragraph for each offence and a corresponding paragraph for the resulting injury. An example of

how multiple applications should be incorporated into one form is available from the Magistrates Court.

2. The Court will open one file for all the applications and all documentation lodged on that file shall specify which application it refers to if not all applications. For example there may be the need for an extension of time for some of the applications and not others. The application for extension of time should clearly identify the offences to which it refers as should the affidavit in support.
3. All applications will be set down for hearing together.

Family Court Practice Direction: No 1 of 2006 FAMILY LAW AMENDMENT (SHARED PARENTAL RESPONSIBILITY) ACT 2006 TRANSITION DIRECTIONS - PARENTING CASES CURRENTLY LISTED FOR TRIAL
