This month sees the 30th anniversary in the Supreme Court Northern Territory of Lenore Keyte.

Lenore started at the Court as personal assistant to then Deputy Master Stephanie Forgie (at a time when the Court still also exercised Federal Court and Family Court Jurisdiction). She worked with a number of Masters and Deputy Masters and Registrars (and acting appointees) including Narendra Patel, Phil Lefevre, Terry Coulehan, Peter Liddle, Viv Holmes, Jenni Daniel-Yee, Margaret Rischbieth

and for a brief, acting period, myself, at an early stage becoming Registry Manager.

She did not work at the Supreme Court the whole time, becoming (for a while) Secretary to the Agents Licensing Board, before returning to her true "home". Lenore's contribution to the exercise of the Court's Civil jurisdiction, and to the operation of the legal profession, has been considerable. If she wrote her memoirs she would also have a few stories - it is probably best they remain unwritten!
