As well as being a valuable resource for residents of the Territory, local business and service providers, it is also a great resource for the legal profession.

provide advice in clinics with a very limited amount of time and the Law Handbook is often a first point of call to find information about an issue and what legislation in the Northern Territory relates to it. I think the Handbook is an essential legal resource for practitioners."

Barkly Region Legal Services Poster

Where can you go to for help with legal problems in the Barkly Region? Many people who have legal problems don't know what services are available to them or which is the most appropriate to help with their problem.

At times the law and legal system can be complicated and overwhelming for people who don't know where to turn. For this reason, the Northern Territory Legal Aid Commission in conjunction with legal services in the region have created a poster for the Barkly Region promoting legal services and advertising their contact details. The Poster was launched in Tennant Creek in September.

The Northern Territory Legal Aid Commission, Central Australian Aboriginal Legal Aid Service, Central Australian Aboriginal Family Legal Unit and Central Australian Women's Legal Service deliver a range of services which include. legal resources, information and initial advice, assisting people at court for criminal matters, advice and representation in family law, domestic violence and children's matters. Also, the public can contact them to speak to someone employment issues. about compensation, complaints, welfare matters, motor vehicle accidents or anything else they are unsure about.

These organisations know how vital it is for people to have access to help and information that can explain their rights and obligations and provide confidential help in culturally appropriate ways. This poster is a valuable community tool and will be displayed by many organisations in the region.
