# NTBA bi-annual Civil Conference

The decision to hold what is only the 2<sup>nd</sup> NTBA Conference up in Dili; East Timor is a bold and progressive one and deserving of strong support. We are all hoping that the Conference is a success and pays dividends for the attendees and for the future as regards relations between our neighbour and the Northern Territory Legal Profession.

The programme is sparkling with no shortage of top shelf speakers. The locale is extremely positive and brave, as East Timor, a seriously struggling country, is very much a neighbour of Australia, and in particular Darwin. It's not without significance that the anniversary of the Darwin Bombing is also the anniversary of the Japanese Invasion of Dili, namely the 19 February 1942.

Further, the East Timorese endeavours in resisting the Japanese invasion which included their alliance with the Australian Commando groups who were heroically stationed there is one

of the great chapters in Australian Military History.

The endeavours of the "Sparrow Brigade" and the incredible assistance given to them by the Timorese peoples, justifiably goes down in the annals as one of the great achievements of Australian Military history. This country will always owe a large debt to the peoples of East Timor for their incredible assistance and huge losses in the Second World War.

The relationship was of course soured by the Australian Government's conduct during the Indonesian Invasion and the subsequent Pine Gap Treaty and some of these aspects will touched upon during the The Conference Conference. is also attracting the interests of the Law Council of Australia and its International Division as well as Law Asia itself. It can only augur well for the future, for our profession and the pursuance of the Rule of Law in East Timor.

The Conference itself will be seeking to build on links that have already been established between Northern Territory Supreme Court Judges and the Timor Leste Judges. In recent years there have been meetings between both said Judges here in Darwin and in Dili.

The Conference theme will be Common Issues/Common Solutions? And, in particular:

1. The Tensions between Western Legal Systems and the Customary Law of



Legal Issues Relevant to Resource Exploitation in the Timor Gap.

There will be a host of impressive speakers including:

- Professor Hillary Charlesworth, one of Australia's most highly regarded experts in public international law and human rights.
- Also speaking will be Bernard Collaery, former ACT Attorney-General, and presently the lawyer representing Timor Leste in the current arbitration proceedings in The Hague, and whose legal offices in Canberra were raided recently by ASIO.
- Also, Dr. Chris Ward, (Public International Law Specialist and Barrister from Sydney), who advised and represented Timor Leste in its boundary negotiations with Australia.

The Conference programme will actually be in two parts with the main programme being backed up by a programme directed specifically towards the continuing professional development requirements for Territory practitioners.

Sessions in this programme will be presented by Northern Territory Judicial Officers and members of the Northern Territory Bar Association and will focus on; - Civil Procedure reform in the Supreme Court and the
