conference in Dili, Timor Leste has remained an important part of our focus for 2015.

The Bar Association, jointly with the Supreme Court and the Law Society, recently hosted the visit to Darwin for the Opening of the Legal Year lunch of his Excellency Judge Deolindo Dos Santos of the Timor Leste Court of Appeal. Following the expulsion of Timor Leste's Portuguese-speaking judges and prosecutors late last year, the NTBA have been working with the Supreme Court to establish closer links with the judiciary in Timor Leste. Judge Dos Santos attended as the

representative of Timor Leste's most senior judge, the President of its Court of Appeal, his Excellency Guilhermino da Silva, following an invitation from Chief Justice Trevor Riley. In addition to meeting some of our judges, magistrates and practitioners and visiting the CDU law school, Judge Dos Santos was able to spend some time observing cases in our courts. He has indicated that this kind of experience would be very valuable for his colleagues in Timor Leste.

As a result of this visit, Timor Leste's Consul-General in Darwin, Mr Francisco Jose Filipe, wrote to the Association formally seeking:

... to continue and further enhance the relationship that has developed between the Courts, and I think there is much to be gained on both sides. As you are well aware the Timorese Judges and Lawyers need to be exposed to the efficient administration of courts, how to manage criminal and civil cases both in court and administratively. For these reasons and others, urgent legal assistance is needed in capacity building in the following areas:

- · Commercial Law
- Arbitration
- · Mediation
- · Juvenile Justice
- Domestic Violence
- Legal terms in English (to be able to deal with present/future international commercial contracts).

## 2016 Dili Conference 13 to 16 July 2016

The NTBA will be running its biennial civil law conference again in Dili, starting with a cocktail party on Wednesday evening 13 July and finishing with the conference dinner on Saturday 16 July 2016. One of the themes of the conference will be independence, both in terms of the judiciary and the profession. We are particularly interested in fostering a constructive discussion Timor Leste not just about the importance of judicial independence but also about the responsibilities which go with it. Further, and we hope with the support of the International Bar Association, we will look at issues of independence at a regional level, including examining the development of independent bar associations not just in Timor Leste (soon to be the subject of a specific IBA programme) but also in Myanmar and Cambodia and their importance for the rule of law.

Important themes from 2014 will also stay on the agenda, including the on-going problems with domestic violence in both jurisdictions and an update on

the Timor Gap negotiations and other resources issues of common interest. Finally, we will continue to include "black letter" commercial law and practice topics of interest to Territory practitioners and which we hope will also be of interest to Timor Leste practitioners.
