

Omits data between 1998-2001













### **DEMOGRAPHICS OF THE PROFESSION**

Over the past 3 years the number of NT practitioners has declined—507 at the 2016 census date, compared to 548 in 2015 and 533 in 2014.

The number of male practitioners has declined by 25% over the past 3 years compared to a decline of 5.5% in female practitioners. For the previous two years the split of the profession was 52% female to 48% male. This shifted somewhat significantly in 2016—58% of practitioners are female.

Whilst the number of newly admitted lawyers continues to be steady with 32 lawyers admitted by the NT Supreme Court during the 2016 calendar year, women are joining the NT profession at a much greater rate—in 2016 78% of admittees were female.

A significant proportion (44%) of practitioners have been practising for more than 10 years post admission and these practitioners are divided almost precisely in equal numbers between male (50.2%) and female (49.8%) practitioners.

Conversely however it appears that female practitioners aren't staying in the profession in equal numbers past the age of 50. In the 25 to 29 age group female practitioners vastly exceed the number of male practitioners (74% to 26%). This percentage steadily declines until the 45 to 49 age bracket where the division between male and female practitioners is 46% to 54%. From 50 onward the number of female practitioners continues to decline whilst male practitioner numbers are more steady.

The geography of the profession in the NT hasn't changed significantly in the past 2 years—for 2014 19.6% of the profession was located outside Darwin and Palmerston. In 2016 81.5% of the profession could be found in Darwin and Palmerston and 18.5% in other regional areas, largely Alice Springs and Katherine.

In 2016 there were 40 barristers in the NT, of which 9 (22.5%) were female. This is a slight decline on overall barrister numbers, down from 46 in 2014 and 2013 and means the Bar now represents just over 7.5% of the profession.

Practitioners in private practice constitute 35% of the profession in 2016, which has declined compared to 3 years ago—in 2013 private practitioners made up 41% of the profession.
