KELLIE GRAINGER CEO, Law Society NT -

The Society's Annual Report for 2018/19 has been published and can be found on the Society's website. I encourage you to take a moment to read about the hard work of the Society's many committees as well as statistics about the various regulatory functions of the Society—see how many practising certificates were issued last financial year, the number of complaints and enquiries received and trust account compliance.

The recent publication of the 2018 National Profile of Solicitors also gives us an opportunity to compare the make-up of the NT profession with other Australian jurisdictions—take a moment to read the article on page 13 to see where we stand in the big picture.

Following the adoption of the new constitution for the Society in November 2017 work has been underway to update the governance document for the NT Young Lawyers (NTYL). When the NTYL came under the Society's umbrella many years ago a Standing Order was adopted to provide for its structure and governance. Over the last year the Society's Governance Committee has been working with the Executive Committee of the NTYL to review and update this document and re-make it as a By Law under the current constitution. This work is almost complete and we are working toward having the new By Law in place in time for the start of next year.

The Secretariat has welcomed a new member of staff, with Patrick Berends joining us as our new Complaints Investigator. The creation of the new Complaints Investigator role last year was part of the re-focusing of the Society's resources to ensure that complaints can be considered and dealt with in a timely fashion. Whilst there will be a period of time before the full benefit of this change is felt, and visible in our annual reported data, we are striving for the more timely resolution of complaints.

As another year draws to a close it's an opportune time to reflect on the changes facing the profession. The profession is experiencing the benefits and challenges of technology and the need to adapt and utilise technology to make us more efficient and effective (but not redundant!). There are cultural issues within the profession that we must face and deal with—sexual harassment and bullying being two that have emerged on the national stage as needing a new approach to effect change to make the profession a better and safer workspace for all. The Society continues to explore how it can best serve the profession in addressing these concerns.

The Society is also facing its own changes. The end of this year will see the Society in new premises (more information to come about that). It will also see the final edition of *Balance* as a printed copy delivered to your letterbox each quarter. We are moving with the times and next year our quarterly journal will be published electronically. We hope that you will embrace this new format and it will make reading *Balance* more accessible—just think you'll be able to read it whenever and wherever you are.

As busy as we get with Christmas fast approaching I hope you have the opportunity to pause and reflect on the year that has been, and contemplate the year that is to come and the opportunities that may be waiting just around the corner.

And finally, from the Secretariat we wish all our members a happy and safe festive season. ■
