I am very pleased to be here tonight to acknowledge an important new provider of legal services in this State, Herbert Geer. Nicol Robinson Hallets was, accordingly, born in turbulent times, which may have generated the endurance which has ensured its success over the following 120 years. It even survived the adventures of briefing me when I was a practising barrister in the 1970's.

The other distinguished partner, Herbert Geer and Rundle, this year celebrated a "mere" 69th anniversary, and over that span of years, it developed to the point where these firms

The result, as "The Australian" newspaper informs us with undoubtedly scrupulous accuracy, is the second fastest growing law firm in Australia, with the expectation of a 60% increase over the next 12 months.

Now growth and size are not definitive of quality, as we know, but they are a reliable indicator of client satisfaction, and client satisfaction comes from good, reliable, informed, expert service.
